1) Welcome & short introduction to new members

Current chair ED introduced the Friends and welcomed new members. The role of the friends in raising funds for the school as well as providing hospitality during school events was shared. ED also shared that she had given a short speech to new year 7 parents to introduce the friends in July.

2) Friends of School Committee Roles

AH has served as Treasurer for many years and announced her decision to step down this year. LW expressed an interest in the role. ED to discuss further requirements with LW in transitioning into role of treasurer and becoming a trustee.

The motion for LW to transition into Treasurer role was well received and not contested.

RMS agreed to stay on as Secretary for another year, the motion was well received and not contested.

ED and MC have been Chair and Vice-Chair for the past three years and announced in May that they would be standing down. No one volunteered for these roles.

RMS thanked them for their service.

RMS discussed the need for the Friends to operate in a more decentralized manner, with different members potentially taking on greater responsibility for specific events for example a "team lead" taking ownership for specific events, like NH with the forthcoming fashion show. This would alleviate some of the pressure officers may face as they could then focus on the overall running of the organization, helping and assisting as needed. Implementation and ideas for the same can be discussed further in upcoming meetings and confirmed.

In the meantime, AE noted that the Friends' constitution called for the presence of a Chair and vice-chair. For the time being and as no one had volunteered for the role RMS agreed to smooth the transition by chairing the upcoming Friends meetings and assisting until an outcome was agreed.
